## TOWNSHIP OF CHESTERFIELD ORDINANCE 2024-10

A CAPITAL ORDINANCE OF THE TOWNSHIP OF CHESTERFIELD PROVIDING FOR A FULLY FUNDED CAPITAL IMPROVEMENT PROJECT AND APPROPRIATING \$ 100,000.00 FOR ACQUISITIONS AND IMPROVEMENTS FOR BASIN FOUNTAINS & BUBBLERS FUNDED FROM THE CHESTERFIELD TOWNSHIP OTHER TRUST FUND - BASIN MAINTENANCE

**BE IT ORDAINED** by the Township Committee of the Township of Chesterfield as follows:

<u>SECTION 1.</u> There is hereby approved as capital project within the Township of Chesterfield, but not limited to, the Acquisitions and Improvements for Basin Fountains & Bubblers:

<u>SECTION 2.</u> There is hereby appropriated from the Chesterfield Township Trust Fund – Basin Maintenance the sum of \$ 100,000.00 to cover the cost of the projects described in Section 1.

<u>SECTION 3.</u> This ordinance shall take effect upon final adoption and publication in accordance with the law.

SECTION 4. The Capital Budget of the Township of Chesterfield is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency therewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the capital budget and capital program as approved by the Director of Local Government Services is on file with the Clerk of the Township and is available for public inspection.
