

## TOWNSHIP OF CHESTERFIELD

### NOTICE TO BIDDERS

Notice is hereby given that sealed bids will be received by the Township of Chesterfield, New Jersey, for the 2024 Recreation Improvements Project Re-Bid (the "Project"), for Chesterfield Township, until **10:00 AM prevailing time on Wednesday, July 17, 2024**, at which time the bids will be opened and publicly read aloud at the Chesterfield Township Municipal Building, 295 Bordentown-Chesterfield Road, Chesterfield, New Jersey 08515. Bids received after the designated time shall be deemed unresponsive and shall not be opened.

The project includes acquisition and construction of a gazebo structure and related concrete improvements at Olivia Way Park and a dugout structure and related concrete improvements at the cricket pitch adjacent to Steed Lane.

Drawings, Specifications, and Contract Documents for the proposed work, prepared by Environmental Resolutions Inc. (Project No. 42203 00) have been filed in the Office of the Township Engineer, Environmental Resolutions, Inc., Consulting Engineers, at 815 East Gate Drive, Suite 103, Mount Laurel, New Jersey 08054, and may be inspected by prospective bidders during normal business hours.

Bidders may obtain copies of the Drawings, Specifications and Contract Documents from the Township Engineer's office upon payment of thirty-five dollars (\$35.00). Checks should be made payable to Environmental Resolutions Inc. The payment for contract documents is non-refundable. If contract documents are to be mailed, there is an additional \$15.00 fee for postage.

Bids must be made on the standard Bid form contained within the drawings, specifications, and contract documents, in the manner designated therein and required by the specifications. Further, bids must be enclosed in a sealed envelope bearing the name and address of the bidder and the Project title on the outside, and addressed to: Township Clerk, Chesterfield Township Municipal Building, 295 Bordentown-Chesterfield Road, Chesterfield, New Jersey 08515.

Each bid must be accompanied by (i) all documents listed on the Bid Document Submission Checklist, as applicable, and (ii) a bid guarantee in an amount not less than Ten Percent (10%) of the total bid price as established in the Bid, not to exceed Twenty Thousand Dollars and Zero Cents (\$20,000.00). The bid guarantee must be in the form of a bid bond, certified check, or cashier's check, must be drawn to the order of the Township of Chesterfield and must be delivered simultaneous with the sealed bid.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq., N.J.A.C.17:27, and all other applicable laws referenced within the drawings, specifications and contract documents.

The Township of Chesterfield reserves the right to (i) reject all bids pursuant to N.J.S.A. 40A:11-13.2 and (ii) to waive minor informalities and/or non-material exceptions in any bid should it be in the interest of the Township of Chesterfield to do so. Further, the Township of Chesterfield shall

reject any bid that contains material nonconformities or conditions, or which is materially nonresponsive. In the event the Township of Chesterfield does not reject all bids as permitted under N.J.S.A. 40A:11-13.2, in accordance with N.J.S.A. 40A:11-4, and other applicable laws, the Project will be awarded to the lowest responsible bidder.
