AN ORDINANCE OF THE TOWNSHIP OF CHESTERFIELD TO FIX SALARIES, WAGES AND COMPENSATION OF PUBLIC WORKS EMPLOYEES OF THE TOWNSHIP OF CHESTERFIELD FOR THE YEARS 2024 THROUGH 2027

BE IT ORDAINED that the Township Committee of the Township of Chesterfield in the County of Burlington and State of New Jersey hereby determines and fixes the salaries of the officials and employees of the Township of Chesterfield as follows:

BE IT FURTHER ORDAINED that all salaries are retroactive to January 1, 2024.
