RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CHESTERFIELD AUTHORIZING THE RENEWAL OF THE TERM OF AN INTERLOCAL SERVICE AGREEMENT WITH BORDENTOWN TOWNSHIP, BORDENTOWN CITY, MANSFIELD TOWNSHIP, NORTH HANOVER TOWNSHIP, FLORENCE TOWNSHIP, NEW HANOVER TOWNSHIP AND SPRINGFIELD TOWNSHIP CONCERNING EXTRA DUTY ASSIGNMENT OF POLICE OFFICERS

**WHEREAS,** Bordentown Township, Bordentown City, Mansfield Township, North Hanover Township, Florence Township, New Hanover Township and Springfield Township are neighboring Townships in Northern Burlington County; and

**WHEREAS**, their Police Departments provide traffic control and other off-duty police services to third parties; and

**WHEREAS,** the municipalities often rely upon each other for additional officers to provide such services to third parties; and

**WHEREAS,** the Township of Chesterfield has entered into an Interlocal Services Agreement with the aforementioned Townships which requires a renewal every 3 years; and

**WHEREAS**, the Chesterfield Township Police Department agrees to accept the rate in effect for off-duty police services to third parties of the municipality in which the officer is providing services; and

**WHEREAS**, the Township of Chesterfield wishes to renew the Interlocal Services Agreement effective January 1, 2023 expiring December 31, 2025;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Chesterfield, County of Burlington, New Jersey, that the Mayor and Township Clerk are hereby authorized and directed to notify the Townships of Bordentown, Mansfield, Springfield, North Hanover, Florence, New Hanover and City of Bordentown that the Township Committee has elected to renew the Interlocal Service Agreement, and provide each Township with a certified copy of this Resolution.
