TOWNSHIP OF CHESTERFIELD ORDINANCE NO. 2018-22

AN ORDINANCE TO AMEND CHAPTER 123 OF THE <u>CODE OF THE TOWNSHIP OF</u> <u>CHESTERFIELD</u> ENTITLED, "HISTORIC PRESERVATION"

WHEREAS, the Historic Preservation Commission's stated purposes include the safeguarding of the heritage of Chesterfield Township, promotion of appreciation of historic resources, and conservation of historic sites; and

WHEREAS, the Historic Preservation Commission is empowered to review all development and permit applications involving the exterior of designated historic landmarks; and

WHEREAS, the Historic Preservation Commission now seeks the authority to, as a condition of approval of demolition, document and catalogue the exterior of any historic building which is declared unsafe; and

WHEREAS, the Township Committee is eager to assist the Historic Preservation Commission in its stated goals, and approves of their proposal to document and catalogue the exterior of historic buildings prior to demolition.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Chesterfield, County of Burlington, State of New Jersey as follows:

ARTICLE I. AMENDED SECTIONS.

A. Section 123-15, "Effect of project approval, denial, appeal" is hereby amended to add the following new subparagraph:

"E. As a condition to the issuance of a permit to demolish a historical landmark, the Commission may require reasonable actions be taken, at the owner's expense, to document the exterior of the historic building, including defining physical features and design elements. Such actions may include, but are not limited to, photographic documentation by a professional photographer experienced in historic preservation, architectural drawings, and computer aided drafting."

ARTICLE II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. <u>Repealer.</u> Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability.</u> In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date.</u> This Ordinance shall take effect upon proper passage in accordance with the law.

Discussion

<u>TDR</u>- Going forward if a TDR preserved property wants to do any improvements they must first go to the zoning officer. If the zoning officer deems further approval is needed, the property owner must appear before the Township Committee for approval prior to going to the Planning Board. Chief Wilson asked Ms. Hoyer to draw up a check list for Mr. McMahon. She agreed to do that.

<u>Beavers</u> – Chief Wilson spoke about the problem we are having with beavers primarily around Recklestown Way. The Environmental Group has been wrapping the trees but are unable to keep up with the destruction. Chief Wilson is worried about the safety of the pubic. Trees are falling down all over the development. Chief Wilson met with an Environment professional with the Department of Agriculture who believed that trapping would be the best option. NJDEP approved and issued a permit for the Township to be able to start trapping beavers right now instead of waiting until the December 26th start of trapping season. Mayor Romeu believes there are a lot of people in town that will be opposed to trapping the beavers. Ms. Romeu suggested reaching out to experts for advice on other options before trapping. Mr. Liedtka said that the beavers are ruining our infrastructures and this could cost the Township a lot of money to fix in the future. Mayor Romeu asked Chief Wilson if he can bring back the Environmental Professional to speak with the rest of the Township Committee. Ms. Koetas-Dale agreed that she also needs more time before making a decision. Chief Wilson agreed to reach out to them and see if they were available.

<u>Old Municipal Building</u> – Chief Wilson met with the realtor regarding the agreement we have. Chief asked the realtor to give us a price based on three categories, the top floor, the bottom floor and both floors to see if anyone is interested in it. However, Chief Wilson is not sure how things will work with the overlap of the building and the Public Works building. Ms. Koetas-Dale asked Chief Wilson to look into sharing wells and septic and a price on a new well and septic.

Chief Wilson said that Aggie cleaned the entire building and it looks great. Chief said that we need to establish a minimum fee and he asked the Township Committee if they are interested in selling the building. Mayor Romeu and Ms. Koetas-Dale were in favor of selling the building. Mr. Hirsh will give all of the Committee people a drawing of all three properties showing were the wells and septics are located. Chief Wilson also said that we are still waiting for the square footage price from the realtor. Ms. Koetas-Dale made a motioned seconded by Mr. Liedtka for Chief Wilson to move forward. All were in favor.

<u>Community Development Block Grant</u> – Joe Hirsh will complete the grant application to make the front entrance doors of the Municipal Building handi-cap accessible.

<u>Budget Advisory Committee</u>- Mayor Romeu said that so far there are four residents that are interested in being a part of this committee. Wendy Wulstein, CFO, Ms. Koetas-Dale and Mayor Romeu will work on the Committee as well.

Comments to the Public and Committee

Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to open to the public. All were in favor.

Mike Stein - 19 Greenview Drive - believes we should rent out the old municipal building instead of selling it. He feels it is more profitable to rent over time and this way the Township is still in control of what is done with the building. Mr. Stein asked about the status of the gas pump. Chief Wilson replied that we are working on getting it fixed. Mr. Stein also reported that Chesterfield Hose Co. received a new utility truck.

Paul Cincotta - 15 Gallop Way - spoke about the beavers. A lot of the trees in the development are damaged he said and they are not being replaced. Mr. Cincotta asked if the developer still gives the Township \$3,000 per house into our Recreation Fund. Ms. Hoyer said they are required to pay \$3,300 per unit.

Donna & Salvatore Nalbone - 216 Bordentown-Chesterfield Road said that their farmland assessment for this year has been denied and wants to know why. Ms. Hoyer said they need to appeal with the County.

Chris Markley - 10 Tutor Court - The beavers are a big problem and suggested called Burlington County about the west nile virus since the beavers are holding water. Mr. Markley said that the west nile virus is on the rise this year.

Hearing no further comments, Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to go into Executive Session at 8:12 PM. Mr. Gillespie will update the Committee on litigation matters, pipeline & compressor station update and personnel. All were in favor.
