REPORTS & DISCUSSION

ENGINEER REPORT:

Joe Hirsh stated they are currently working on the following:

NJDOT Municipal Aid FY 2024-Margerum Road – Mr. Hirsh submitted a proposal to PW Director Troy Ulshafer for his review and recommendations.

NJDOT Municipal Aid FY 2025 – Grant is due 7/1/2024. Mr. Hirsh and Troy are currently looking into what roads need work.

Mayor Litt asked Mr. Hirsh to explain how he goes about choosing grants. Mayor Litt would like to have a sub-committee to focus on grants. Mr. Hish will put together a memo with what they have done historically in the past and send it to the Township Committee.

DCA-Local Recreation Improvement Grant – This grant is for the parking lot pavement at Fenton Lan Park. It has been advertised and bids are being taken on May 29th.

Olivia Way Park Gazebo/Dug out @ Cricket Pitch – Both have been advertised and taking bids on May 29th.

Emergency Generators @ **Pump Stations 1 & 2** – Contracts should be finalized by Monday and then generators can be ordered.

Ms. Koetas-Dale asked Mr. Hirsh if he is concerned about all of the patches on Sykesville Road. Mr. Hirsh stated he wanted it documented for the maintenance bond inspection. If there are more patches and they start blending together he may have them mill and repave the road.

Ms. Hughes asked if we have heard back from the DEP regarding the letter they are supposed to issue. Mayor Litt replied no and he plans to send out a letter to them in the morning. Ms. Hughes would like to expedite it and says it is unacceptable we have been waiting for a few months. Ms. Hoyer said she will reach out to Assemblywoman Katz.

MAYOR:

Mayor Litt stated that he and Troy met with Fire Chief Lynch and spoke about the current EMT space and what is needed. They are currently waiting on an estimate. Mayor Litt and Troy also discussed the future of the DPW. Mayor Litt and Troy will be bringing something in front of the Township Committee soon.

Mayor Litt thanked Rachel for organizing the 2nd Memorial Remembrance and asked that she get the word out as she did last year.

ADMINISTRATION:

Rachel reminded everyone of the Porchfest this Saturday from 1pm – 7pm.

PUBLIC COMMENT

Ms. Hughes made a motion seconded by Ms. Blazic to open the meeting to public comment. All were in favor.

Susie Mahon - 16 Chesterfield-Crosswicks Road, stated that the HPC meeting minutes from March were not posted until today. She asked why the April 11th Township meeting minutes were not approved at the April 25th meeting. She said she is following up on meeting minutes not being posted or approved in

a timely matter. She said the March 28th Township minutes were not posted until May and she says this is not being transparent and is not acceptable.

Ms. Mahon asked if the police officers have an AED device in each car since the town does not have 24 hour EMT coverage.

Hearing no further public comment, Ms. Koetas-Dale made a motion seconded by Ms. Blazic to close public comment. All were in favor.

COMMENTS FROM THE COMMITTEE

Mayor Litt stated that Chesterfield does have 24 hour EMT coverage through MTAC however they come from Mansfield at night and on weekends. Ms. Hoyer pointed out that all of the police officers and Fire Department are EMT certified.

Ms. Hoyer stated that she did not realize she had not posted the March 28th Township meeting minutes until recently and the April 11th meeting minutes were just approved tonight.

Ms. Koetas-Dale reported the Green Fun Fair was very well attended and was a great event. She thanked DPW, Troy and Rachel for their help.

Ms. Koetas-Dale reminded everyone that the Alliance is hosting a Music in the Square next Thursday in Village Square Park at 6pm with the Grouser Girls.

Ms. Hughes would like to have more face time with the police officers and would like them to interface more with the residents. She suggested "National Night Out" and "Coffee with a Cop" as some events to consider.

Ms. Blazic made a motion seconded by Ms. Koetas-Dale to approve Resolution 2024-5-8 to go into closed session to discuss Township Administrator candidate at 7:49 PM. Action may be taken.

Ms. Koetas-Dale made a motion seconded by Ms. Blazic to return to regular session at 8:09 PM.

Ms. Koetas-Dale made a motion seconded by Ms. Hughes to adjourn the meeting at 8:09 PM. All were in favor.
